"The General Secretariat of the Council of the European Union presents its compliments to the Macao Economic and Trade Office to the European Union and has the honour to refer to the Agreement between the European Union and the Government of the Macao Special Administrative Region of the People's Republic of China on certain aspects of air services, signed at Macao on 23 November 2013, and, in particular, to the Bulgarian and Maltese language versions, in which clerical errors have been detected and proposes to correct these errors as indicated in the pages attached.

Any objections your authorities might have to these corrections should be communicated in writing to the General Secretariat by 1 April 2018. In the absence of any such correspondence, the texts will be corrected as indicated.

The General Secretariat of the Council of the European Union avails itself of this opportunity to renew to the Macao Economic and Trade Office to the European Union the assurances of its highest consideration."
