Note of the Kingdom of Bhutan, of 11 January 2000

The Embassy of the Kingdom of Bhutan in India presents its compliments to the Embassy of the People's Republic of China in India and has the honour to confirm on behalf of the Government of the Kingdom of Bhutan that the Government of the Kingdom of Bhutan and the Government of the People's Republic of China, both desiring to further develop the friendly relations between the two countries, have, through friendly consultations, reached the following agreement concerning the maintenance by the Government of the Kingdom of Bhutan of its honorary consular post in the Macao Special Administrative Region:

- 1. The Government of the People's Republic of China agrees that the Government of the Kingdom of Bhutan may maintain its honorary consular post in the Macao Special Administrative Region, with the Macao Special Administrative Region as its consular district.
- 2. The honorary consular officer may be a citizen of either side or a third country which has diplomatic relations with the People's Republic of China, but shall not be a stateless person, and he/she must be a permanent resident of the Macao Special Administrative Region of the People's Republic of China.
- 3. The Government of the Kingdom of Bhutan shall not appoint any honorary consular officer, once it has appointed a career consular officer in the Macao Special Administrative Region.
- 4. The honorary consular officer shall perform his/her consular functions within the scope of the Vienna Convention on Consular Relations and the relevant laws and regulations of the People's Republic of China, and will enjoy the corresponding privileges and immunities
- 5. The two sides shall, in a spirit of consultation and cooperation, handle consular matters between them in a friendly manner and in accordance with the Vienna Convention on Consular Relations and international practice.

If the above points could be confirmed by the Embassy of the People's Republic of China on behalf of the Government of the People's Republic of China in a note of reply, this note and the note of reply from the Embassy of the People's Republic of China shall constitute an agreement between the Government of the Kingdom of Bhutan and the Government of People's Republic of China, and shall enter into force as from the date of the note of reply from the Embassy of the People's Republic of China.
