憶及《國際海事組織公約》第 28(b)條關於本委員會的職責,

又憶及《1974年國際海上人命安全公約》(以下簡稱為"公約") 第 VIII(b)條關於適用於除第 I 章的規定以外的公約附則的修正程 序,

在其第 77 屆會議上審議了根據公約第 VIII(b)(i)條建議的並 散發的公約修正案,

- 1. 根據公約第 VIII(b)(iv)條通過了公約修正案,修正案的正文列 於本決議的附件;
- 2. 根據公約第 VIII(b)(vi)(2)(bb)條,決定所述修正案將於 2006年1月1日被視為接受,除非在此日期之前,三分之一以上公約締約國政府或合計商船隊噸位不少於世界商船隊總噸位 50%的締約國政府對修正案提出反對意見;
- 3. 請《安全公約》締約國政府注意,根據公約第 VIII(b)(vii)(2)條,修正案在上述第 2 段所明確的被接受後將於 2006 年 7 月 1 日生效;

經修正的《1974 年國際海上人命安全公約》 第 V 章修正案

第V章

航行安全

第2條一定義

- 1 在現有第3款之後新增第4款如下:
 - "4 船舶 長度係指其總長度。"

第22條一駕駛室視野

- 2 現有第1段的介紹性文字由下文替代:
 - "1 1998年7月1日或以後建造的按第 2.4 條定義的船長不小於 55m 的船舶應滿足下列要求:"

第28條一航行活動的記錄

- 3 將本條的標題改為:
 - "航行活動的記錄和每日報告"
- 4 將現有段落編號為第1款。

- 5 在第1款之後新增第2款如下:
 - "2 500 總噸及以上從事國際航行 48 小時以上的船舶應按第 IX/1 條定義的向其公司提交每日報告,公司將保存該報告和整個航行期間所有後續每日報告。每日報告可通過任何方式傳送,只要它們在報告中命名的位置確定後儘快地傳送至公司,可以使用自動報告系統,條件是它們包括對傳送的記錄功能,且這些功能和與定位設備的界面將受到船長的定期檢查。報告應包含下列內容:
 - .1 船舶的位置;
 - .2 船舶的航線和速度;和
 - .3 影響船舶航行或船舶正常安全營運的任何外部和內部狀 況的細節。

RESOLUTION MSC.142(77) (adopted on 5 June 2003)

AMENDMENTS TO THE INTERNATIONAL CONVENTION FOR THE SAFETY OF LIFE AT SEA, 1974, AS AMENDED

THE MARITIME SAFETY COMMITTEE,

RECALLING Article 28(b) of the Convention on the International Maritime Organization concerning the functions of the Committee,

RECALLING FURTHER article VIII(b) of the International Convention for the Safety of Life at Sea (SOLAS), 1974 (hereinafter referred to as "the Convention"), concerning the amendment procedure applicable to the Annex to the Convention, other than to the provisions of chapter I thereof,

HAVING CONSIDERED, at its seventy-seventh session, amendments to the Convention, proposed and circulated in accordance with article VIII(b)(i) thereof,

- 1. ADOPTS, in accordance with article VIII(b)(iv) of the Convention, amendments to the Convention, the text of which is set out in the Annex to the present resolution;
- 2. DETERMINES, in accordance with article VIII(b)(vi)(2)(bb) of the Convention, that the said amendments shall be deemed to have been accepted on 1 January 2006, unless, prior to that date, more than one third of the Contracting Governments to the Convention or Contracting Governments the combined merchant fleets of which constitute not less than 50% of the gross tonnage of the world's merchant fleet, have notified their objections to the amendments;
- 3. INVITES SOLAS Contracting Governments to note that, in accordance with article VIII(b)(vii)(2) of the Convention, the amendments shall enter into force on 1 July 2006 upon their acceptance in accordance with paragraph 2 above;
- 4. REQUESTS the Secretary-General, in conformity with article VIII(b)(v) of the Convention, to transmit certified copies of the present resolution and the text of the amendments contained in the Annex to all Contracting Governments to the Convention;
- 5. FURTHER REQUESTS the Secretary-General to transmit copies of this resolution and its Annex to Members of the Organization, which are not Contracting Governments to the Convention.

ANNEX

AMENDMENTS TO THE INTERNATIONAL CONVENTION FOR THE SAFETY OF LIFE AT SEA, 1974, AS AMENDED

CHAPTER V SAFETY OF NAVIGATION

Regulation 2 - Definitions

- The following new paragraph 4 is added after existing paragraph 3:
 - "4 Length of a ship means its length overall."

Regulation 22 - Navigation bridge visibility

- 2 The existing text of introductory paragraph 1 is replaced by the following:
 - "1 Ships of not less than 55 m in length, as defined in regulation 2.4, constructed on or after 1 July 1998, shall meet the following requirements:"

Regulation 28 - Records of navigational activities

3 The title of the regulation is replaced by the following:

"Records of navigational activities and daily reporting"

- 4 The existing paragraph is numbered as paragraph 1.
- 5 The following new paragraph 2 is added after paragraph 1:
 - Each ship of 500 gross tonnage and above, engaged on international voyages exceeding 48 hours, shall submit a daily report to its company, as defined in regulation IX/1, which shall retain it and all subsequent daily reports for the duration of the voyage. Daily reports may be transmitted by any means, provided that they are transmitted to the company as soon as practicable after determination of the position named in the report. Automated reporting systems may be used, provided that they include a recording function of their transmission and that those functions and interfaces with position-fixing equipment are subjected to regular verification by the ship's master. The report shall contain the following:
 - .1 ship's position;
 - .2 ship's course and speed; and
 - details of any external or internal conditions that are affecting the ship's voyage or the normal safe operation of the ship."
